Permit this letter to serve as my thanks for a job very well done.

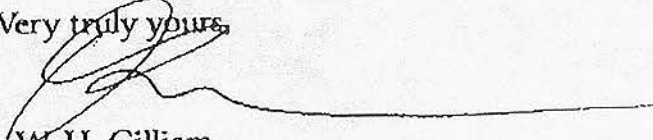

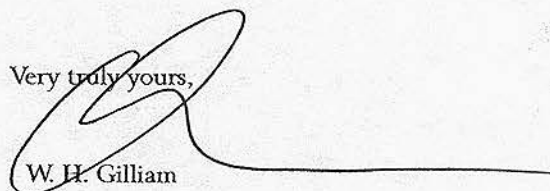
