Now that a final resolution of this matter has been accomplished I want to thank you and The Greenspan Company for the invaluable contributions you made to bring this matter to a successful conclusion.




Now that the China Basin claim has been successfully resolved, I would like to conclude this matter and thank you for your participation and unfiring efforts.
